## 6<sup>th</sup> Division Highlighted Officer of the Week

Officer Watkins has been serving our community since 04-28-2008. All three Officers are assigned 6<sup>th</sup> Division Mid Watch platoon. They received a nomination for Officer of the Month in October. Below is a portion of the letter they received for their efforts.

Officers received a radio run to the intersection of Indian Trail and Indian Oaks Circle on a subject wanted on warrants. Based on information provided the subject was to be considered armed. Officers had dealt with the subject in past. He was located in the parking lot of the business center in front of the barber shop. Officers were able to quickly identify the subject based on their past knowledge. As Officers approached on foot the subject reached into his waist band. They swiftly closed the distance to gain control of the subject. After placing him in custody, Officers located a 9mm handgun in the subject's waist band.

By coordinating their efforts the Officers were able to take the subject into custody in a busy area without incident.



The most prevalent preventable crime in the 6th Division is theft from vehicle. We receive reports on a regular basis from residents that wake up and find that they have been victim of this crime during the night time hours. Almost half of those crimes are committed on vehicles that are left unlocked by the owner the night before. We would like to make the following recommendations to our citizens to help reduce these occurrences.

- **Always lock your car at night!**
- **Please remove non secure valuable items (GPS, cell phone, MP3 player, wallet/ purse, money)**
- **Park in well-lit area or have motion lights installed in driveway / parking space.**
- **If feasible, install a vehicle alarm system that is properly set.**
- **Get to know your neighbors and work together to keep an eye on your street.**
- **If you see suspicious persons walking the street at night please call 574-2111 to have a patrol car check them out.**

While the criminal is the guilty party for committing these crimes it is our responsibility to work together as a community and police department to not make it easy for them. By following these recommendations you will significantly reduce your chances of becoming a victim and create a neighborhood environment that is more difficult for the criminal to be successful.
