FROM THE *Mayor*



Since our summer newsletter, there have been some exciting things happening in Watterson Park. Below are some of the highlights I would like to share.

- **We approved an Ordinance lowering property taxes from 9.5 cents to 8.3 cents per one hundred dollars (\$100.00) of assessed valuation.** This is a 15% reduction and will apply for fiscal year July 1, 2016, through June 30, 2017.
- The installation of decorative street signs and stop signs on residential streets is in the works and scheduled to be completed within the next few weeks. This project involved researching the specifications required to ensure the signage meets Federal standards.
- We attended the LD&T meeting and zoning hearing regarding Bellarmine University's development plans for property located in Watterson Park. Bellarmine owns the properties located at 3408, 3416, 3420, and 3430 Newburg Road and 4300 Champions Trace Lane. The proposal is for athletic facilities that would consist of a fieldhouse, tennis courts, and a sports field.
- Several businesses are expanding or relocating to Watterson Park: Hancock Machine and Tool located on Bishop Lane is expanding; Icee Company located on Hodel Road is also expanding; and Louisville Plate Glass relocated their headquarters to a 60,000 sq. ft. building at 4301 Chefs Way.
- Milldaun Road was paved, which included the installation of speed humps. In addition, improved street lighting was installed.
- Your Mayor, Council, and quite a few residents participated in two successful Neighborhood Walks with the LMPD 6th Division Officers.
- We are now connected on **Nextdoor**. (*See article on page 3.*)
- A community-wide yard sale was held on Saturday, September 24. The sale was advertised in *The Courier Journal* and on Nextdoor, Facebook, and other social media sites. There was quite an increase in the number of shoppers.
- Seventeen trees, which were planted by the City of Watterson Park, were removed. Many of these trees were ash trees and were dying as a result of the emerald ash borer.
- We resolved several parking, traffic, and property issues. (*Ongoing.*)
- We worked with JCPS Administration regarding middle and high school assignments for our students. (*Ongoing.*)
- We attended monthly LMPD 6th Division Citizens Advisory Board Meetings to ensure a good rapport with the Officers assigned to our area, which is Beat 3. (*Ongoing.*)
- We attended District 10 Advisory Board Meetings in order to stay informed of what is happening in our District. (*Ongoing.*)

### ROBBERY PREVENTION TIPS FOR BUSINESSES

The Louisville Metro Police Department investigates crimes that have been committed and is dedicated to helping prevent future criminal acts. We are pleased to provide you with the following business robbery reduction tips. By following these recommendations, you may reduce the likelihood of becoming a victim.

- Ensure signs, posters, and displays do not obstruct the view from the outside.
- Keep parking lots and all entrances free from obstruction and well lit.
- Install quality video surveillance equipment. Periodically ensure the equipment is properly working and is recording the front door and, secondarily, the register areas (if applicable).
- Install height markers on main entrances.
- Make sure employees are trained on the use of the store's security system(s) and what to do in case of a robbery.
- Limit the amount of cash kept in registers. Maintain limits by making cash drops in a safe or other location when appropriate.
- Make eye contact and greet customers as they enter the store. Customers like attention; robbers do not.
- Stay alert. Watch for suspicious people or vehicles. Call the police and report suspicious activity immediately.
- Have at least two employees working at all times.
- Count money in a secure location away from public view.
- Keep suspect description forms at each register. Ensure employees know how to complete them.

There are a number of things you can do to protect your business and reduce your chances of becoming the victim of a robbery. Inexpensive modifications to your business, or changes in the way your business operates, can create obstacles for a robber that will increase the chances they will be identified and caught. When their chances of being identified and captured increase, criminals often look for an easier target.



### **REGINA AVENUE**

Regina was originally recorded as Avenue, it is on Metro Logic maps as Avenue, and the Post Office and Emergency Services have it listed as Avenue. Google Maps show it as Lane, so we have notified Google to change it to Avenue.
